## Expression of Interest for Conducting International Buyer Seller Meet during India International Seafood Show (IISS) 2023

#### A. Introduction

The Marine Products Exports Development Authority (MPEDA) (hereinafter referred as "Authority') is a statutory body under the Ministry of Commerce and Industry, Government of India. MPEDA with its Head office at Panampilly Nagar, Kochi is entrusted with the primary task of promotion of export of marine products from India.

MPEDA in association with Seafood Exporters Association of India (SEAI) is organising the 23<sup>rd</sup> edition of IISS (India International Seafood Show) from 15-17 February at Biswa Bangla Mela Prangan at Kolkata, West Bengal. The biennial exhibition will showcase the entire gambit of the seafood industry having seafood exporters with a range of high quality seafood, manufacturers of processing/packaging/equipment and other vendor suppliers to this industry. The theme for the 23rd edition of IISS is "The World's Seafood Basket".

The event comprises of following components;

- 1. An exhibition with around 200 exhibitors in 364 stalls, more than 2500 delegates and more than 5000 visitors for three days.
- 2. Technical sessions on first two days by renowned speakers from the industry, regulatory authorities from major importing countries and other experts.
- 3. International Buyer Seller Meet (IBSM): As part of promoting Indian seafood exports, MPEDA is planning to conduct IBSM at Biswa Bangla Mela Prangan at Kolkata, West Bengal from 15<sup>th</sup> to 17<sup>th</sup> February 2023. IBSM will provide a platform for direct interaction between buyers/ importers from top 25 countries including G20 countries and Indian seafood exporters. It is envisaged to bring 50 seafood buyers that can positively collaborate with Indian exporters for increasing exports. The followup events with various markets will be continued for one year in the online platform.

In this regard the organising committee of IISS is looking for a suitable experienced agency that can take the responsibility of identifying minimum 50 international seafood buyers and bring them to India to attend the IBSM.

#### **B. Process Description**

Expression of Interests (EoI) in prescribed format are invited from reputed firms for "Conducting International Buyer Seller Meet during India International Seafood Show (IISS) 2023 & series of Virtual International Buyer Seller Meetings (hereinafter referred as IBSM) during 2023-24", an event where in buyers/ importers from top 25 countries including G20 countries (List given at Annexure 1) and Indian seafood exporters will interact directly to promote seafood exports.

The response form for the EoI can only be downloaded from our website **www.mpeda.gov.in.** The last date for submission of responses is 03.12.2022 at 10.00 hours. A pre-bid meeting with interested participants will be conducted on 14.11. 22 at 11 30 pm in virtual mode. The interested participants may

submit their interest to participate in the pre-bid meeting to the email id given in. The responses received shall be opened on 05.12.2022 at 1000 hrs hours in the presence of the bidder's representative who choose to be present at the MPEDA Head Office at Panampilly Nagar, Kochi, Kerala during the evaluation process. **The EoI with Technical & financial bid need to be submitted for evaluation**. Bidders Qualified in the technical evaluation will be called for an online/offline presentation either at MPEDA Head Office or through online platform. After the technical evaluation and presentation, the financial bids of the bidders who score marks above 70 only will be opened.

Those who are meeting the eligibility criteria and are interested to conduct IBSM subject to the terms and conditions may furnish their interest in the prescribed form enclosed herewith and with copies of other required documents indicated in this document.

#### C. Eligibility Criteria

#### (i) Essential

- The vendor should have minimum 2 years experience in conducting IBSM services.
- 2. The vendor should have conducted at least 3 IBSMs with minimum 25 participants.
- 3. The bidder shall be reputed firm (herein after referred as "Vendor") having Average annual financial turn over during the last 3 years ending 31st March 2022 should be at least Rs.30.00 lakh and above..
- 4. The vendor should have audited balance sheet for last 3 years.
- 5. Vendor should have GST registration
- 6. IBSM Work Completion certificates.
- 7. Declaration from the bidder to the effect that the bidder is not under ineligibility by any authority shall be submitted.

#### (ii) Desirable

- 1. Awards / certificates of excellence received, if any.
- 2. The bidder should have good database for buyers from seafood sector.
- 3. The bidder should have conducted at least one buyer seller meet in seafood sector/ food sector.

#### D. Definitions

1. IBSM- International Buyer Seller Meet is an event conducted online/ offline, where in an offline platform will be provided for direct interaction between buyer & Indian seafood exporter resulting in increase of seafood trade from India.

2. Buyer- representative of international seafood purchasing company/ wholesale/ retail outlets/ restaurant chains/ supermarkets with a minimum experience of 5 years in the respective sector.

#### E. Terms and conditions

- The vendors will have to submit an interest free, refundable earnest money deposit (E.M.D) of Rs. 3,00,000 (Rupees Three lakh only) in the form of a Bank Draft / Pay Order of Scheduled Commercial Bank drawn in favour of India International Seafood Show payable at Ernakulam. The DD should be submitted to Deputy Director Market Promotion, MPEDA Head Office Kochi 682036. Before Bid opening date.
- 2. The vendor shall not sublet whole or part of the work to any other agency, in case of award of contract.
- 3. Vendor shall submit a Performance Security Deposit of 3% of the tender value in the form of bank Guarantee
- 4. The vendor shall deliver their services, in accordance with the contract to the complete satisfaction of the Authority.
- 5. Vendors are advised to understand the magnitude of the job involved before submitting the bids.
- 6. In case of default on the part of the agency in carrying out any order, Authority shall be entitled to get the work done by any other persons and all expenses consequent thereon or incidental thereto shall be borne by the Authority and will be deducted by the Authority from any money due or it may become due to the agency.
- 7. The decision of the Authority in the matter arising out of this contract shall be final and binding in regard to all matters relating to the contract.
- 8. Canvassing in any form by the agency directly or by any other agency / person on their behalf may lead to disqualification of their bid.
- 9. Please note that falsification/suppression of information shall lead to the disqualification of the vendor.
- 10. All cases/proceedings relating to any dispute or claim arising out of or any case of performance of this contract shall be falling in appropriate court having jurisdiction in Ernakulam, Kerala.
- 11. In the event of the vendor committing breach of any of the above terms and conditions or the services of the vendor being found to be unsatisfactory, the contract can be terminated by the Authority even before the expiry of the period of agreement by giving 5 day's notice to the vendor. Even otherwise the

- Authority will have the right to terminate the engagement of vendor by giving 10 day's notice.
- 12. The Authority shall have right to issue addendum to tendered documents to clarify, amend, modify supplement or delete any of the condition, clause or items stated therein. Each addendum shall form a part of the original invitation to EOI.
- 13. The Authority reserves the right to accept or reject the EOI response without assigning any reason thereof. No claim or complaint in this regard will be entertained by the Authority.
- 14. The Authority is under no obligation to accept the lowest or any EOI received in response to this EOI notice.
- 15. The response should be signed on all the pages by the Authorised signatory along with seal of the vendor.
- 16. Resolution of the Company (if the vendor is a Company) authorizing the person signing the EOI, to sign the EOI on behalf of the Company is to be provided.
- 17. In the event of the vendor committing a breach of the contract, the Authority is entitled to receive from the vendor compensation to the extent of loss incurred as determined by the Authority for any loss or damage caused to the Authority.
- 18. Details of personnel involved in the project shall be intimated in the Technical Bid and the same personnel shall be retained till the completion of the project. In case of change in personnel, the substitute shall have equivalent profile.
- 19. The venue for the programme is Biswa Bangla Mela Prangan, Kolkata, West Bengal from  $15^{th} 17^{th}$  February 2023
- 20. If there is a requirement of Advance Payment, the schedule of advance payment may please be mentioned explicitly in the Financial bid.
- 21. Maximum advance payment is limited to 30% subject to
  - a. Acceptance of work order.
  - b. Submission of bank guarantee equivalent to the advance amount.
  - c. Submission of Performance Security Deposit equivalent to 3%of contract value.
  - d. Remaining 70% would be settled, after one month of submission of bills and other required documents.
- 22. Agency shall submit a bank Guarantee equivalent to the amount of advance released.

- 23. EMD amount of successful bidder will be retained as security deposit and will be adjusted during the final settlement.
- 24. EMD of unsuccessful bidders will be returned after the show.

#### F. Selection Method & Criteria

#### **BRIEF DESCRIPTION OF THE SELECTION PROCESS**

Two Bid selection process based on Quality and Cost Based Selection (QCBS) for evaluating the Bids has been adopted for selection of Event manger comprising

- b) The Technical Bid and

#### (c) the Financial Bid.

Bids are required to be uploaded as follows: -1: Technical Bid: -2:Financial Bid

The Bidding process shall be a two-stage process. Prior to the detailed evaluation of the Technical Bids, MPEDA shall determine whether each bid is

- a) Complete
- b) Is accompanied by the required information and documents towards Eligibility Criteria and
- c) Is substantially responsive to the requirements set forth in the EoI document

The evaluation shall be based on the technical and financial parameters. The weightage for the technical parameters shall be 70% and the financial parameters shall be 30%.

a) Technical Weightage (St): The marks scored by the bidder in technical evaluation shall be calculated to 70 points as below:

St = T\*0.70 where T is the Technical score awarded to the bidder as per Technical Evaluation Criteria

b) Financial Weightage (Sf): The marks scored by the bidder in financial evaluation shall be calculated to 30 points as below:

The Commercial scores of all the other proposals will be determined by Sf = 30 \* Fm/F (Fm = Lowest evaluated EoI cost, F = value of Commercial proposal under consideration).

c) Final Selection: Proposals will be ranked according to their combined technical (St) and Commercial (Sf) scores. The combined technical and Commercial score shall be calculated as S = St + Sf.

The technical evaluation criteria are broadly defined as under. Bidder has to provide documentary proof against each criteria as a part of technical proposal.
